### **Directions:**

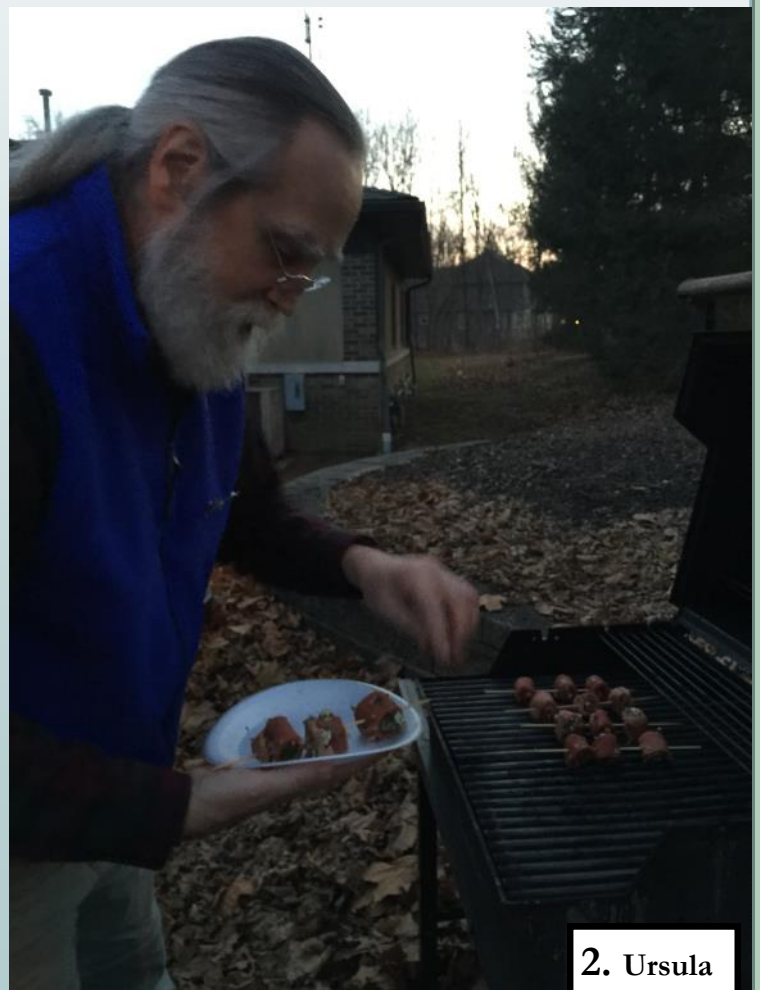
Take 280 to exit 7. Turn left at the light onto Pleasant Valley Way.

5. This offer is extended to anyone listening on this list and you may share this offer with anyone you wish, we welcome all the data. Please understand we will proceed at our pace through the data as it arrives.
6. You may also include Swampies for whom you would like us to advocate for kingdom level awards. Before you do, consider the gravity of the award and what likely supporting information will be required. It could be just an accurate synopsis, pictures of work, and a list of future events the person will be attending.
7. Its a good idea to aquatint yourself with the kingdom award submission form if you have not already. The more information we get, the less legwork we have to do, the more likely it will get before their majesties in a timely fashion. All these things can lead to success, but are not always required.

## Officer Meeting Minutes—March 2017

### 2017 March 9 Baronial Officers' Meeting

Present: Alexander, Galefridus, Judith, Jehannine, Miles, Jonathan, Teresa, Maerhild, Treannah, Wulfgar, Brennan (taking minutes), Michelle Hasselmann, Perote, Mark Saladini, and Jerry (the contact person for the Mudthaw site)

Needed 8 for a quorum; had 8 plus Orlando ready to vote by phone if needed.

**Minutes** from January 2017 were approved with no corrections.



### Report of Recent Events

Galefridus reported on the third meeting of the **A&S Food Group**, held Friday, March 3. Charis came and taught cheese-making. The next gathering is Saturday, April 8<sup>th</sup>, when we will be visiting a number of local ethnic grocery stores.

The barony received a nice thank you letter from the Montville First Aid Squad for the free will donation we collected and gave them after using their meeting room in February.

### Upcoming Events

#### Ducal Challenge:

- The event announcement was sent out to the officers for comment. It will be going up in the next couple of days.
- The Elks ask that we wait on the contract until “later.” They have us written in for the date, but wanted to work on the Quest contract first.
- Brennan noted that the contract specifies that no pets are allowed. This is more of an issue for Quest. We discussed the issue and agreed that we need to clarify this with the Elks.
- At the first Quest using this site in 2015 we arranged with the Elks that dogs would be permitted, only on a leash, cleaned up after, and not allowed in some parts of the site.
- At the second Quest in 2016 we did not talk to the Elks about it but followed the same guidelines as the year before and it was fine.
- This year they have a different contact person. We don’t want to lose the site over this issue.
- Erec will talk to the Elks about this.



## Officer Meeting Minutes—March 2017 (continued)

- It would be unfair to people attending Quest to have them arrive with their pets and find out that the rules have changed. We need to let people know if the previous arrangement has changed.

### Quest:

- The contract with the Elks has been signed.
- See discussion of pets above.



### Crown Tourney:

- Dayboard cook is arranged. Martyn de Halliwell will be doing it, and bringing his own outdoor kitchen.
- We will be using the porch of the Grange Hall to serve the dayboard and for the auction. That means we need fewer EZ ups. Troll will be at the gazebo. Looks like we only need them for changing rooms and MoL.
- Preregistrations will be sent to Mabel Fortune, as Miles' deputy. Caera will be running the gate on the day of the event.
- The site and one of the vendors need our tax-exempt information. Galefridus asked where to find it and was pointed to the file on the SCA.org website.
- The site is very bare. We have the use of one empty barn. How many tables and chairs should we rent? We are expecting as many as 500 people. Do people need tables to eat at? Discussion of the topic concluded that we need 2 table for MoL, 2 for Gate, 4-5 to serve dayboard, 4 for the auction, and 18-22 for people to eat at. The decision was to rent 30 tables that seat 8 each, and 150 chairs. Most people bring their own.

### Black Gryphon Inn:

Alexander reported that plans are going well; it is fully staffed. This is an easy event to pull off, especially compared to Mudthaw. This year the event is Viking-themed. Because this year BGI is taking place in April we may be able to do something outside as well.

### Mudthaw:

- The schedule has changed to add another court on the field in the middle of the afternoon.
- We discussed the schedule, and how to make it work better. The issue is volume—so many people come between 10 and 11 that the lines can get long. The schedule is very tight this year because of needing to hold two courts and the baronial investiture.
- The concern was expressed about long lines for fighters trying to get through troll with enough time to start fighting on time. The schedule is very tight. In previous years we have tried having a second gate out by

the fighting field, but that didn't work any better.

- Decided to open the gate half an hour earlier at 9:30.
- Royal rooms: like last year we can't have food in the classrooms. The food will be in a table in the kitchen. We discussed the plans, and left it to Maerhild, Matthais, and Treannah to work out the details.
- Service for the high table has been arranged. Service for the rest of the room is needed.
- Mudthaw is considered fully staffed.
- No children are allowed in the kitchen. Eating is not permitted in the kitchen either.
- Only the kitchen staff should use the kitchen bathrooms. There are large bathrooms elsewhere and portapotties outside.
- Wulfgar needs help breaking down the lists after the tournaments end.



Charis is running a savory sale at Mudthaw, providing lunch items. She asked what we would like the money raised from the sale to go to. It was agreed that the royal travel fund would be the recipient.

### Other Business:

**List Stands:** Work on the new list posts is coming along nicely. .

**Date of next Mudthaw:** We asked Jerry to check whether March 24, 2018 would work for the event next year. March 25 is Greek Independence Day, and the church may want the building for that. A week earlier won't work because it would conflict with Gulf Wars. A week later will be the Saturday before Easter, not ideal. Jerry will get back with us on whether the 24<sup>th</sup> works.

### Officer Reports:

The March Mudpuppy has been published and looks good. Ursula is still recovering from foot surgery.

Miles reported that Mabel Fortune, his deputy, has been added to the bank accounts. BGI reservations are coming in. He is prepping the 1<sup>st</sup> Quarter report.

Jonathan said all the stuff that had been out has been returned to the storage locker. (One drink container is still at his house.) Settmour Swamp now owns the storage locker; the transfer happened a couple weeks ago. Pick-up for Mudthaw is going to happen Friday morning.

Maerhild reported that she has heard from no new contacts. She will make sure there is Gold Key at Mudthaw and Quest.

Oguur reported that there is fighting.

Ursula has finally gotten her warrant as deputy webminister.

Meeting adjourned. The next meeting will be in April.

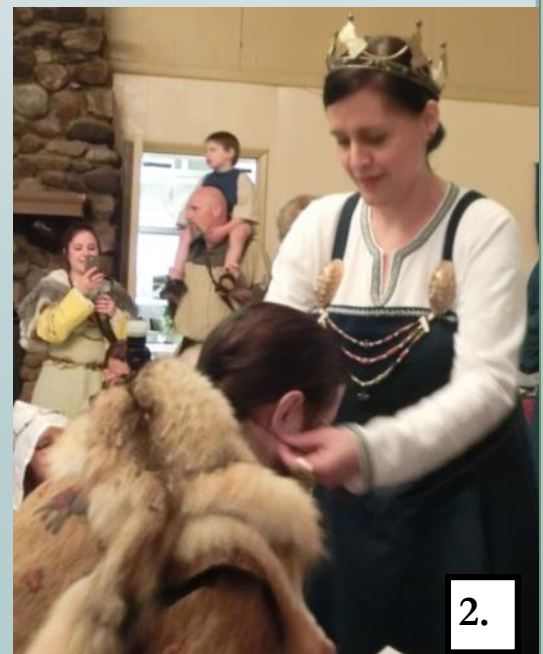

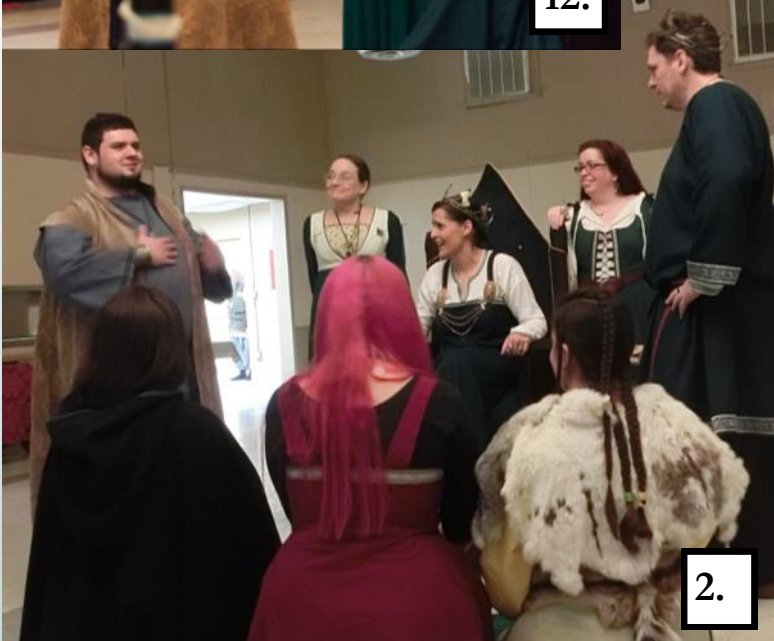

## Food and Cooking Workshop (April 8)

On April 8th, thirteen intrepid food enthusiasts in our Barony took off adventuring, visiting five specialty markets in one day. We returned to the Montville First Aid Squad at the end of our shopping spree to sample whatever we purchased and cook with the ingredients we found. The cavalcade headed first to the edge of Clifton and Paterson to **Nouri Brothers Market** for foods of the Middle East. In the store we split up, some heading for the drums and section of gifts and tchotchkes. Others made straight for the extensive olive bar, while still others wandered the aisles of the grocery store. From there we went down the block to **Fattal's Bakery**, where we bought more groceries and ate a delicious (and inexpensive) lunch that included falafel, kibbe, and shawarma. Well filled, we headed toward Parsippany where we visited **Top Quality Food Market** for east Asian foods. Their fish selection is extensive and reasonably priced and like the other stores, they sell dishes, pots and pans, and groceries. From there we went a short distance down the road and stopped briefly at **Patel Brothers**, a South Asian market. Our last site was **Big Delight Bazaar**, another South Asian market. This large store sells clothing, groceries, and cooking supplies, but it is known for its produce section, which takes up almost half the store.

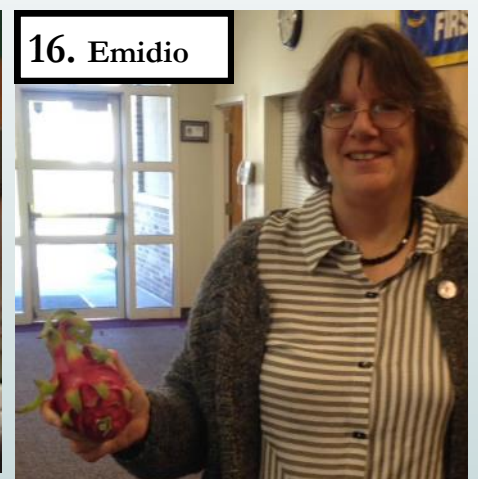

**Big Delight Bazaar** 1470 US Route 46, Parsippany, NJ (near the corner of Baldwin and 46)



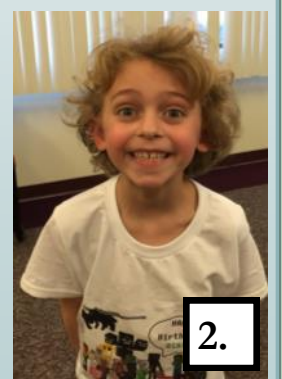




## Food and Cooking Workshop (April 8, continued)

Back at the First Aid Squad house we shared some of what we had purchased: dragon fruit, stuffed grape leaves, fresh halvah, fresh baked pita, hummus, and numerous other goodies. **Brighid** used the Long gourd she found at one of the South Asian markets to make a 15th century Spanish dish for all of us to sample. **Maerhild** and **Aziza** made some yummy Persian cardamom cookies. **Baroness Ursula** organized a project to make the tokens for QUEST. Several others joined us and we were able to assemble the quest tokens while sampling and chatting. When asked which store the group liked the most, Nouri Bros. was top on their list because it was so different and more of Old World feel. All the other stores were larger, brighter, more targeted toward a modern American shopper. Everyone agreed: now that they had visited these stores, they would be sure to return.

## Quest Introduction and Rules by Galen

### Quest Introduction and Rules

1. There must be three (3) adult persons in an adult party. Obstacles will not give problems or solutions to any group of people of less than three, excepting lack of people at the initial gathering and selection of party members, or if there is an emergency during the Quest necessitating the withdrawal of someone in a party, or if there is a late entry into the Quest. All groups should contain at least one adult, though this may be waived if parents of all three group members agree. All groups will be given a token (this paper) by the Quest-o-crat which they will show to the Obstacles before attempting the obstacle. They must show it again if they return to the obstacle. There may be more than three questers in a group if the surplus members (over 3) are not adults or children over 12 years of age. In many cases, though, no more than three members of a group may participate in a particular obstacle, if an obstacle depends upon physical challenges to three members, etc. Obstacles will explain this where necessary.
2. Obstacles may vary in number, may stay in place or may be wandering, and may or may not be clearly marked as obstacles. There may or may not be a best order to solve the Obstacles in for optimum speed of Quest solution. The Obstacles may or may not give false clues. A party may or may not have to solve all the obstacles to solve the entire Quest. Part of the fun is figuring out what you're supposed to do. Obstacles should confirm answers, and not react to flip answers. IE, ask "Is that your group's answer?"
3. As Questers arrive at the Obstacles, if there are other groups there ahead of you, you may either all wait there in a line for your party's turn to attempt the obstacle, or you may all go to another obstacle instead. You may not "save your place in line" at one obstacle while going to another. No cutting in line. No "frontsies-backsies". Sheesh! No baksheesh.
4. No unarmed fighting or using any weapons of any sort (real, heavy, fencing, siege, throwing, archery or boffer, unless weapons are provided by people playing obstacles in the Quest). You may bring them along for your own persona reasons, but **you may not use them. Period.**
5. In all cases where you do not initially solve or succeed at an obstacle, you must do one of the following things before trying that obstacle again: a) Wait there for three minutes; if no other party comes to the obstacle in that time, you may try again. If a party or parties do get there, your party must take your place in line after them, after the three minutes are up. Or, b) Try another obstacle before you return to the obstacle you had trouble solving.
6. The first party who solves the quest shall receive their prize(s), to be awarded later in Baronial Court. Winners must be present to receive their prize(s), or must notify the Quest-o-crat as to whom may claim it for them. Winners must give their modern names and addresses to the Quest-o-crat, who gives this info to the Exchequer, who needs it for yearly reports to Corporate. To save time and paper, if you win just write them on the back of this paper and hand it to the Quest-o-crat and then go back to having fun.
7. Don Quixote is disappointed with the dreary decadence of daily life, and seeks to revive knight-errantry in a world devoid of chivalric virtues and values. We invite you to help Don Quixote find the true meaning of chivalry.
8. Good luck to all, and have fun!
