Ducal Challenges Baronial Court Sept 9, 2017

The Court of Baron Jonathan and Baroness Teresa At the Ducal Challenges

Their Excellencies thanked all for attending, and thanked **Baroness Charity Dale** for the excellent dayboard.



Duke Brennan and **Duchess Caoilfhionn** were called before the court to announce the winners of the day's tournaments.

There were 20 entrants for rapier and 21 for the armored combat.

At the end of the day, **Don Devillin MacPherson** bested **Master Thomas delbroc** in the finals of Duchess Caoilfhionn's tournament and took home the Glastonbury chair made by Thomas delbroc. **Sir Culann Mac Cianain** bested **Lord Ozurr the Boot Giver** in the finals of Duke Brennan's tournament and took home a bench made by **Sir Jan Janovich** and **Lord Arne Ulrichsson**.



The A&S Baronial Champoin, **Lady Aurelia**, called into court **Lady Sof'ia Zhirinskaia** as populous choice for her Rose page from Grand Heures d' Anne de Bretagne.



Their Excellencies then called into court **Lady Aibhlin Inghean ui Phaidin**, and announced her as the new Baronial Arts and Sciences Champion. Her entry was glass beads that were beautifully made and wonderfully researched.

The Coronation is coming up soon with details published here.

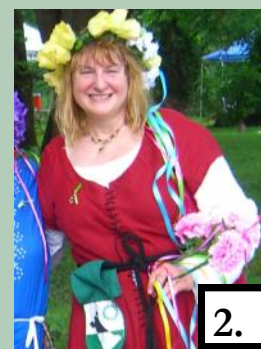

Business Meeting Notes August 30, 2017

Minutes of the Baronial Officers' Meeting

August 30, 2017

Present: Jonathan, Teresa, Elizabeth, Ursula, Kasia, Judity, Galefridus, Jocyn, Orlando, Brennan, Jehannine. We had a quorum.

Before the meeting Ursula helped a number of us add the software for EK officer email to our phones and computers. It wasn't straightforward, and we're grateful for the assistance.

Minutes from July meeting were approved.

The meeting began with a discussion of changes announced at Curia this past Birka about kingdom emails. It no longer works to automatically forward emails sent from officer@settmourswamp.eastkingdom.org to our personal email accounts. We have to work with the Kingdom server for security reasons. The kingdom email system isn't that easy to use, but it provides a historical record (probably from backups) of issues that we might need proof later of how it was handled. Ursula spoke with Lord Joel of Vestfell, who is now the kingdom webminister, and was told they are working hard to take the kingdom to a gmail system. Anyone else who needs help getting their emails set up should see Ursula.

Also at that Curia they asked that the key people working on events have emails specifically for that event. Doing this solves the problem of the poor impression presented by people who may have inappropriate email addresses. Kingdom would like the autocrat, the person doing feast, and the one running troll, and anyone else whose email would appear in the event announcement to have a kingdom email for the event. Galefridus did this for Crown Tourney. Ursula volunteered to set up some emails for autocrat1@settmourswamp, autocrat2...autocrat3. We often have more than one person working as an autocrat at the same time, planning different events. There is still some question of how to handle emails used when someone is preparing a bid and has not yet become the official person running the event, whether using their personal email then is okay.

Upcoming Events

Ducal Challenges:

Brennan reported that he feels like the event is in pretty good shape. He needs two more people to help Saturday morning.

The Elks have said that Charitye can use their grill to prepare dayboard. On Tuesday Brennan plans to meet with Miles to pick up two checks—one to pay the remainder owed to rent the site, and the other is \$500 seed money for troll. He'll cash that second check and bring the money Saturday morning. MOLs are all set.

Judith is running troll and training Mabel how to do it. We anticipate giving comps to 11 people: baron, baroness, Oskar, dayboard cook, autocrat, and royals. Brennan has not planned to use tokens. He has been advertising this event for 10 months and expects people to come from three kingdoms. The language in the event listing needs to be changed to reflect that members get discounts (not that nonmembers pay a surcharge).

An area under the pavilion has been set aside for the baronial A&S competition. There's also a place for Youth A&S display and activities. Kit has volunteered to do an A&S consultation table, where they help people with what they need to work on in their A&S projects, including helping them understand what they'll be judged on in competitions. Kit can use a table under the pavilion. Two merchants are coming.

Jonathan and Teresa volunteered the use of their medieval pavilion for the prize tables. MOL bring their own table. Troll needs one. We will need all four of the baronial tables for displaying prizes. All the popups should be brought from storage for use by troll and changing rooms.

Court is likely to take two hours. The baronial court has one item of business—the new A&S champion.

Brennan's main concern on the day is making sure the tournaments run in a timely fashion. Last year fencing ran 45 minutes longer than heavy.

Brennan will order insurance immediately, but because it is late we will have to pay extra.

**Business Meeting Notes August 30** (continued)**Coronation:**

Elizabeth Lovell reported that plans are moving along well, and their highnesses are very excited. Bethany Ostening, Ducette de Verdun, will run troll. We have arranged to use PayPal for preregistrations. There is a 33¢ fee for each transaction we will be charged. We can't charge extra as a convenience fee, according to Society rules on PayPal use. We could raise the price per person for everyone to \$15.50 or \$16 to cover this cost, but the group felt it was not a good idea since the event announcement with the \$15 price has already been posted. The hope is that by making preregistration easier, the lines at troll will move faster. Ursula asked if the use of PayPal is covered by SCA insurance to protect from credit card theft. Stacey will seek clarification on this question, but using PayPal is how the Society is now doing credit cards—they must have considered this question. Jehannine asked about whether it was an problem that troll is being run by someone not in the barony. Stacey said Doucette has baronial folks working with her at troll, but will also check with Miles about whether this is an issue. Site tokens are being made by Master Stefan of Silverforge. He's looking at doing something using a design based on Russian coins. Elizabeth thinks the cost won't be too high and she'll find the money in her budget to cover the cost.

A Facebook page has been set up to help corral people working on the event and give them an easy place to communicate with each other.

Perote Gormal Campbell is the dayboard cook. Dayboard is being provided, not an evening feast. It means the event ends earlier and the royals don't have to stay late. It's also simpler for us. Their highnesses are working with Perote on the dayboard menu; discussions are presently centered on dessert. Stacey hopes to post something in the event announcement within the next week or so about the menu. We are also looking at what foods to provide as snacks for their new majesties to have on snack trays behind the dais for them during court. She'll talk with Peter about including something with mango.

Galen has agreed to run the games between the two courts. They'll have kubb and a Viking game played with a box and a bag where two blindfolded people try to hit each other with their bags. Ivan loves this game. Galen is also planning on period table-top games and needs space for that. He will have people teaching those games during lunch.

The doors will open at 9:30. We can set up on Friday (probably around noon), and staff will be able to get in at 8:30 on Saturday for final set-up. We can arrange the chairs for court on Friday. When can we expect to be done on Saturday? The docket for court is known now, but the math problem needs to be worked out. Our hope is to be cleaned up and out by 7:30. The current majesties are not staying after they step down so their royal

room can probably be cleaned up early. We'd like to use that room as the photo booth. Jonathan recommended that if we need more rooms (like one for photos) that we arrange that with Gerry at the church as soon as we can.

We'll have 3 changing rooms, and 2 royal rooms. Ursula volunteered to set up the royal rooms, and Mathias will help. We should provide something for snacks for the last court since lunch won't be ready yet. Ursula thought \$50 will cover this expense.

Decorating the hall: Oscar went by and took measurements of the stage and room. He is aware of the site's rules about props. All the baronial banners that Antonio made for Mudthaw a couple years ago will be there. We have large baronial banners with our arms and long silk banners that usually hang with them. They are in a bin in storage. Would Oscar find those useful? Erec made a stand for hanging all these banners, but it looks like what Oscar has in mind won't work with that set up since his design will cover the whole back wall. When will Oscar's decorations up? Ahead of time or between the two courts? Brennan thought we could engineer something to make it possible to display the baronial banners. We'd like them to be up, even if it's not in front.

We discussed the traffic patterns of people moving in and out of court. We may need people movers and bouncers because there is a tendency for people to cluster at the back of the room and block the doorways, making processions a bit difficult.

The largess display can be set up in the rotunda. Folks will see it as they walk through that area to changing rooms and to get photos taken. It will be run by Countess Violante do Porto and needs to be added to the event announcement. We've had problems before with too much noise in the rotunda so people can't hear, but this noise issue shouldn't be a problem with largess. Troll will be in the main hallway, which worked well at Mudthaw.

Elizabeth needs seed money for troll. Also Perote is likely to need some money up front to pay for food he is purchasing.

Elizabeth will work on applying for insurance tomorrow. Judith will send her the instructions.

We're expecting around 250-300 people.

**Business Meeting Notes August 30** (continued)**Past Events**

Demo: We did a large demo at Canal Days in Wharton on August 19th. A number of folks turned out to help with the demo. We had several A&S pop-ups and folks did calligraphy, illumination, sewing garb, fiber arts... Galefridus did a cooking demo and prepared two dishes. Ursula made a Maypole and got people involved in dancing. We've been invited back next year and also received invitations to several other demos. Galefridus commented that a number of people asked if they could taste what he was cooking—is this something we'd like to do next time? It raises issues of food safety, additional insurance, liability... We agreed that it was best not to feed the public. The timing of this demo was difficult because it was so soon after Pennsic—it was hard to do all the preparation on time. Judith (with Caera's and Jonathan's input) designed a banner we'd hoped we could get made in time, but Staples turnaround time was too long. But now we have it for the next demo. It's a permanent banner with our barony's name, arms, SCA, website. The banner was shown to everyone (and an official picture taken for the Mudpuppy). The officers voted to cover the \$43 cost of having the banner made.

Other Business

Who has Restaurant Depot cards? Thor, Jehannine, and Charis each have one. Judith has none, but scanned a card into her phone.

We need to find an autocrat for Mudthaw. We already have the date and have signed the contract with the church.

Is Caoilfhionn planning on doing another fencing gig this coming February? Details?

Officer Reports:

Chatelaine: Jehannine needs to give Judith details so Jehannine can be officially recognized in this position. She'll do that at the end of the meeting. She wasn't able to go to the demo because of a prior work commitment

but helped in planning for the demo. She's thinking of having a "newcomers guided tour" at Mudthaw.

Fencing: Orlando said it was going great, with lots of newcomers coming to the practices. They've had no accidents and no issues. The Glen Gardner site has backed off some. We'd like to have even more people involved so Orlando is planning to post announcements of the practices in the southern region. He's been looking into alternate sites for practices, but the cost is high and some are concerned about insurance issues (weapons).

Food & Cooking A&S: Galefridus said the next get together will be on the 16th at South Mountain Reservation where we'll be cooking over fires. We rented a pavilion so we can hold the gathering even if it rains some. There is lots of grill space. We discussed that it also a good place for a Swamp Stomp. The next A&S Cooking gig after this one will be October 20th, a Friday evening, at the Montville First Aid Squad. Ursula said she would add the October 20th listing to the Mudpuppy to give people time to plan to come. In November he's thinking of doing it on the 17th, the night before 100 Minutes War.

A&S: Kasia reported that a number of people came to the last A&S Thingy at her house. They worked on weaving and spinning. About five people came, not a bad turnout.

MoL: Nothing to report.

Chronicler: Ursula hopes to get the Mudpuppy out September 1st. Dalek has plans for more changes to the webpage (Ursula does the updating; he does the designing). Aife, the deputy Chronicler, has written an article for the upcoming Mudpuppy.

Meeting ended.
