#### From the South:

Take 287 North to 22 West, and proceed as from the East. **OR** Take 206 North go through the Somerville Circle, and past Rt. 22. Do not get onto 287 N. Pass the Green Knoll Grille and a car dealer on the left. Turn right onto Highland. The Alternative, a consignment shop, will be on the far right corner. From Highland, make the first right onto Somerset and the first left onto Orchard. #230 is the fourth house on the right, on the far corner of Prospect and Orchard.

#### From the East:

Take 22 West, past the intersection with 287.

Take the Commons Way exit towards the Bridgewater Commons Mall.

Turn right at the second light onto Prince Rodgers Ave.

Turn left at the first light onto North Bridge St.

Continue on North Bridge Street for about half a mile. Just past Temple Shalom, turn left onto Wight Ave. Make the second right onto Hillside. Make the first left onto Orchard. #230 is the second driveway on the left.

#### From the West:

Take 22 East to 202-206 North. Do not get onto 287 North. Pass the Green Knoll Grille and a car dealer on the left. Turn right onto Highland. The Alternative, a consignment shop, will be on the far right corner. From Highland, make the first right onto Somerset, and the first left onto Orchard. #230 is the fourth house on the right, on the far corner of Prospect and Orchard.

#### From the North:

Take 287 South past 78. Where 287 splits, you can take either part, but the left one is easier. Take Exit 17 for 206 South, Somerville/Flemington. From 206 South, take the Commons Way exit. This exit comes up very fast! Turn right at the light onto Commons Way. Turn right at the next light onto Garretson Rd, which changes to Woodlawn.

Go about a half a mile, crossing over the 206 bridge and turn Left onto Somerset Ave. Make the second right onto Orchard St.

#230 is the fourth house on the right, on the far corner of Prospect and Orchard.

Take I-287 to US-202 (Exit 17). Go South on US-202 to Flemington NJ Make first right in circle to get on NJ-31 North. Follow signs to Hospital; make first Left past the hospital onto Gaunt Place, church is on left.

#### From Route 78 (western NJ / PA)

Go East on I-78 to NJ-31 (Exit 17). Take Route 31 South. Follow signs for Hospital; take right onto Gaunt Place, church is on left.

#### From Northeast Jersey/New York City

New Jersey Turnpike south to I-78 West Take I-78 express lane west towards GARDEN STATE PARKWAY/CLINTON. Merge onto I-78 express Lane west. Take exit 29 for I-287 South towards Somerville (RT 202/206) Take exit 17 (202/206 south) towards SOMERVILLE (US 22 W)/FLEMINGTON. Stay straight to go onto US-202 South until you reach Flemington. #### FROM ROUTE 287 SOUTH

Take exit 10 (Rt 527 & Easton Ave). Once on the exit ramp, get into the left lane and follow the Davidson Avenue/U-turn signs to get on Route 527 North. Go to the first traffic light, and turn left on Davidson Avenue. The site is the first parking lot on your right.

#### **FROM ROUTE 287 NORTH**

Take exit 10 (Route 527/New Brunswick/ South Bound Brook). At the first traffic light turn left on Davidson Avenue. The site is the first parking lot on your right.

#### FROM GARDEN STATE PARKWAY NORTH

Take Turnpike exit 9. After the tollbooths, stay to the right and follow signs for "Route 18 North-New Brunswick." (see below)

#### FROM ROUTE 18 NORTH

After going through New Brunswick, you will pass the exits for Route 27 (Highland Park), and for George Street. Take the next right-hand exit for Route 527/Easton Avenue. Turn left at the traffic light onto Landing Lane, then right at the next light onto Easton Ave. Take Easton Avenue about 3.5 miles, past the exits for Route 287, and turn left at the light onto Davidson Avenue. The site is the first parking lot on your right.

(NOTE: If you miss the Easton Ave exit and take Rt 18 over the John Lynch Memorial Bridge, take the first exit and turn right onto River Road. Go 3.5 miles to Route 287 North, and follow those directions.)

#### From Route 287

Go I-287 to US-202 (Exit 17), go southwest on US-202 to Flemington, NJ. Make first right in circle to get on NJ-31 North. Follow signs to Hospital. Make first left past hospital onto Gaunt Place, church is on left.

#### From Route 78 in Pennsylvania

Go East on I-78 to NJ-31 (Exit 17). Go South on NJ-31. Follow signs for Hospital. Turn right onto Gaunt Place, church is on left.

#### From New Jersey Turnpike

South to I-78 West/New Jersey Tpke Ext East Ramp towards Exits 14 To 14C/Cars-Trucks-Buses. Merge onto I-78 West Ramp. Take I-78 Express Lane West towards Garden State Parkway/Clinton. I-78 Express Lane West becomes I-78 West. Take I-287 (Exit 29) towards Somerville (US-202/206). Merge onto I-287 South ramp. Merge onto I-287 S. Take the US-202 South/US-206 South exit (Exit 17) towards Somerville (US-22 W)/Flemington. Stay straight, get on US-202 South until you reach Flemington. Take first right on circle to stay on NJ-31 North. Follow signs to hospital, make the first left after the hospital onto Gaunt Place. Church is on left.

#### From Garden State Parkway

Go North on Garden State Pkwy (Portions toll) to I-195 (Exit 98). Go West on I-195 to I-295. Go North on I-295 to I-95 South. Go South on I-95 South to NJ-31 (Exit 4). Go Northwest on NJ-31 to Flemington Take first right on circle to stay on NJ-31 North, follow signs to Hospital. Make first left after the hospital onto Gaunt Place, church is on left.

#### From Philadelphia:

Go North on I-95 North to New Jersey. Go North on I-95 North to NJ-31 (Exit 4). Go Northwest on NJ-31 to Flemington Go 1/2 way around circle to stay on NJ-31 North, follow signs to Hospital. Make first left after the hospital onto Gaunt Place, church is on left.

#### **Nutley Fighter Practice**

Note: Many of the exit ramps from Rt. 3 are sharp curves.

#### From NJ Route 3, Essex/Passaic County (East or West):

Take the Main Ave, Nutley-Passaic exit. At the bottom of the ramp, make left onto Main. Go past Bradlees to the next light, make a right onto Kingsland. Go to the first light and turn left onto Franklin. At the third light make a right onto Chestnut. Go one block and make left onto Hillside Crescent. The church is on the left-hand side; park on the street.

Alternate directions that will help you avoid traffic:

#### From the South:

Take the Garden State Parkway to Exit 151. At the end of the ramp turn right onto Watchung Ave. At the next light make a left onto East Passaic Ave. Take your second right onto Coeyman Ave. Make the first right onto Bromley Place. Bromley Place turns into Glenview Place. You will come to a stop sign at Ridge Road right after a curve (be careful). Continue straight and Glenview becomes Chestnut St. Continue straight through the traffic light at Bloomfield Ave.\* At the top of the hill at Prospect Street Chestnut jogs to the right. Continue on Chestnut. Take the next right onto Hillside Crescent. The church will be on the left after the curve.

#### From Route 3 Westbound

Take the Passaic Ave exit. At the end of the ramp, make a left onto Passaic Ave. Follow directions from **\*\*** below

#### From Route 3 Eastbound:

Take the Passaic Ave exit. Stay to the right and merge with Ward Ave. At the next intersection (50 ft or so), make a left onto Passaic Ave.

\*\*Passaic Ave turns into Cathedral Ave. Stay to the right at the fork in the road. At the end of Cathedral, make a right onto Kingsland St. Take the first left onto Bloomfield Ave. (across from Roche, at the railroad tracks). Take Bloomfield Ave. to the traffic light at Chestnut St. This should be the second traffic light, but there have been lights added to that road since I lived there. (Chestnut is one of those). The three streets on the left before Chestnut are Raymond Ave., Beech St. and Mountainview Ave. Continue from \* above.


