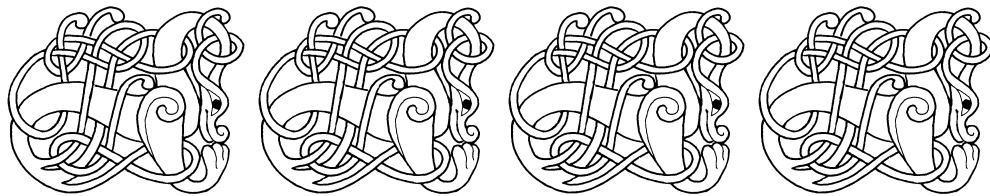

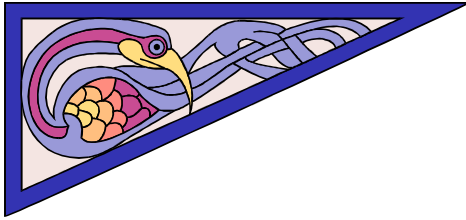

### *Herald - Sinking Tower Pursuivant*

I will be at Quest to run Court. Anyone who is interested in trying out court heralding should contact me and I'll work with you at Quest.

I've had three people express interest in learning book heraldry (i.e., preparing name and device submissions). I will try to coordinate schedules and set up a class at one of the Flemington Sunday practices.

The name and badge of the Iron Tower have passed Laurel and been officially registered. The official name is the Order of the Iron Tower and the official badge is (Fieldless) a tower bendwise sable.

The badge for the Order of the Ivory Tower has passed. It is (Fieldless) a tower bendwise argent. I realize that this has caused some consternation in certain quarters. Let me try to set some minds at ease.

This badge is not the same as the badge registered for the Order of the Silver Tower. As registered with the College of Heraldry, the badge for the Silver Tower is "(Fieldless) A tower bendwise per fess argent and sable." Translated into English, that's a leaning tower divided horizontally in the middle, with the top half white and the bottom half black.

I am told that the badge for the Ivory Tower was originally intended to be a tower made of ivory. Remember that heraldry is an abstract art. A tower made of ivory translates into "heraldese" as a tower argent. A tower made of silver also translates into "heraldese" as a tower argent. I have no idea why "(Fieldless) a tower bendwise argent" was never submitted for the Order of the Silver Tower way back when.

Nevertheless, since the Barony now officially owns "(Fieldless) a tower bendwise argent," we have the right to do with that badge whatever we want. We can continue to give out silver metal towers for the Silver Tower and ivory-colored towers for the Ivory Tower and no one in the College of Heraldry is going to bat an eyelash. I hope this is reasonably clear to non-heralds.

Wednesdays continue to be bad for me for meetings. I have work obligations that run until about 8 p.m., meaning that I would not be able to make most meetings until 8:30 p.m., by which time you guys are likely to be done or nearly so.

The Solstice has come and gone and summer has arrived. Archers of the East, come and celebrate the first weekend of summer in the Barony of Settmour Swamp as we host King and Queen's Archery Champions. We are proud to welcome their majesties Gryffith and Aikaterine and Princessa Gabriella von Ulm to our lands, to witness the finest archers in the knowne world, compete for the honor of being named a royal champion.

In addition to this grand tournament, other activities are also planned. On Saturday, Sir Mitchell McBain will run a double elimination tournament for the fighters. Fencers, you have not been forgotten. Our baronial Marshall of Fence, Lord Edmund Patterson, will host a Southern Region fencing practice. Lord Draguin is making plans for youth combat activities. Merchants are welcome, but please bring your own table. There is no fee to merchant, but you are required to pay the necessary site fees. Please contact the autocrat so she knows how much space to reserve for you.

There is no feast planned, but a hearty dayboard will be provided. Reservations are strongly encouraged and appreciated so that we may ensure all will be adequately fed.

The site is the Teetertown Nature Ravine Preserve, Mountain Farm Section. It's a primitive site, with no buildings and no running water. There is ample room for camping and for parking. Dogs are welcome but must be leashed at all times. The site is **DRY**. This rule will be enforced. This is a new location for our barony and we do not wish to jeopardize our ability to use it in the future.

The gate will open at 5:00 PM on Friday, June 22 and remain open until 10:00 PM. It will reopen at 8:30 AM, Saturday.

**Archery Championship - Saturday**

The archery championships will begin approximately 10:30 AM. Sign up for the tournament will close at 10:15 AM. Archers arriving late and wishing to compete will be able to sign up on the archery range until the first shot is fired. However, you must check in at the gate beforehand. The tournament will be the traditional three round format. All archers will compete in the first round. Thirty-two archers from round one will advance to the second round. The top sixteen archers from round two will advance to the final round.

**About the Site:**

There is no running water on site. The barony will be providing water and Gatorade will be provided courtesy of Lady Raven and the Kingdom Waterbearers. Everyone is encouraged to bring your own to supplement what the barony will provide. The activity fields are bordered by trees which will provide some shade, but shade canopies, viewing galleries and pavilions are encouraged. There will be a shade canopy set up on the archery field. Please bring your banners to display at your campsite or on the archery field. No ground fires are allowed. .

There are stores, banks and gas stations within a 15 minute drive of the site.

**FROM THE SOUTH**

From Clinton/Flemington areas, via State Route #31 North:

Take Rt. 31 North, just past the Hess gas station in Clinton and exit to the right onto Rt. 513 North. Proceed 6.5 miles and turn left just past the A&P store in Califon onto Sliker Road. Proceed 1.5 miles up the hill on Sliker Road, and turn right onto Pleasant Grove Road. Go approximately 0.7 miles, entrance will be the SECOND entrance on the right, after the entrance for the Information Center. There will be an SCA sign posted.

### **FROM THE NORTH**

From Chester/Randolph areas, via Morris/Hunterdon County Route #513 South:

Take Rt. 513 South, past Long Valley and turn right just before the A&P store in Califon onto Sliker Rd. Go 1.5 miles on Sliker Rd and turn right onto Pleasant Grove Rd. Go approximately 0.7 miles, entrance will be the SECOND entrance on the right, after the entrance for the Information Center.

### **FROM THE EAST**

From Somerset/Union Counties, via Route #I-78 West:

Take Rt. 78 West to Exit 24 (marked “523 to 517 Oldwick/Whitehouse”), and turn right onto Rt. 523 North. Go one mile to an intersection with a United Trust Bank branch on the right hand corner – DON'T TURN. (Although Rt. 523 turns right at that light, continue driving straight – road becomes Rt. 517 North.). Go 5 miles on Rt. 517 North to the first traffic light and turn left onto Rt. 512. (Landmarks on Rt. 517: you'll pass through Village of Oldwick, up a hill, past a large white church on the right hand side.) Turn left onto Rt. 512 West and go 4.3 miles to end. (Landmarks on Rt. 512: you'll pass through Califon Borough and over an old white steel bridge over the South Branch/Raritan River.) At the end of Rt. 512, turn right onto Rt. 513 North. Go 0.1 miles and turn left just past the A&P Supermarket onto Sliker Rd. Go 1.5 miles on Sliker Rd, turn right onto Pleasant Grove Rd. Go approximately 0.7 miles, entrance will be the SECOND entrance on the right, after the entrance for the Information Center. SCA signs will be posted.

### **FROM THE NORTHEAST**

From Morris/Passaic Counties, via Route #I-80 West:

Take I-80 West to Exit 26 (marked “Rt. 46 West - Mount Olive – Budd Lake”). Proceed 4.9 miles on Rt. 46 West. Landmarks on Rt. 46: After the Saturn car dealership of Mt. Olive on the right, turn left just past the “Parkade Shopping Center” (Super A&P store), onto Naughtright Rd. Go 2.7 miles on Naughtright Rd and turn right onto Flocktown Rd. Go 1.8 miles on Flocktown Rd and turn left onto Schooley's Mountain Rd. Go 0.2 miles on Schooley's Mountain Rd and turn right onto Pleasant Grove Rd. (Morris Co.). Go 2.5 miles on Pleasant Grove Rd, (Morris County - See NOTE 1 below) and turn left onto Califon Rd. Travel 1.7 miles on Califon Rd (See NOTE 2 below) to entrance. SCA signs will be posted.

**NOTE 1:** Pleasant Grove Road in Morris County does not intersect or have any connection to the Hunterdon County roadway of the same name; the Mountain Farm Section of Teetertown is located on Pleasant Grove Road in Lebanon Twp., in Hunterdon County.

**NOTE 2:** Califon Road in Morris County turns into Pleasant Grove Road in Hunterdon County, at the corner of Middle Valley Road, just beyond the Centenary College Equestrian Center.

### **FROM THE NORTHWEST**

From Warren County, via Route #57:

Take Rt. 57 North or South to the Mansfield/Beattystown area and turn onto Stephensburg Rd. Proceed 1.3 miles up the hill on Stephensburg Rd to the intersection of Pleasant Grove Rd (This is NOT the Pleasant Grove Rd in Hunterdon County, where the park entrance is located - See NOTE 1) Continue driving straight – At this intersection, Stephensburg Rd becomes Califon Rd. Go approximately 1.7 miles on Califon Rd to entrance on the left (See NOTE 2)

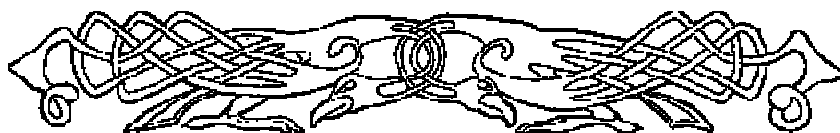

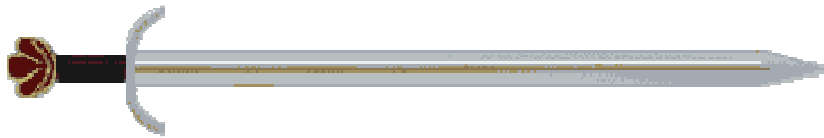
