Starting in April, officers' reports will be included in the newsletter. The officers believe that this is an excellent way for us to keep the populace informed about the current state of the barony.

Also included will be a list of officers who are in need of deputies.

### A Brief History of the Early Coronets of the Barony By Baroness Ursula

The very first Settmour coronet was crafted for Baroness Magda z Stalburg. It was made by Heinrich and it was about too small for Magda's head, only four or five inches across. Heinrich tried hard but Magda never wore it after the coronation.

Baroness Ursula's first coronet was made by Guliermo. Guliermo made the coronet with a three inch by one inch celtic knot holding one tigereye stone in the center. Running from each side are three strands of wire that run around the head. Every four inches there is a gothic arch holding another tigereye. This coronet will be part of the history display at Mudthaw.

Baron Irik's first coronet was made by Dylan and was intentionally similar to the coronet that Guliermo made for Ursula, as requested by the Settmour officers. This caused a huge uproar as Guliermo charged Dylan with stealing his design. Guliermo actually sent an official complaint to Michigan State University (where Dylan got his art degree) charging Dylan with plagarism. It was a terrible misunderstanding. Everyone except Guliermo remembered getting together and agreeing that Irik's coronet should resemble Ursula's coronet. Both Ursula and Irik stopped wearing these first coronets when the controversy started.

Dylan then made gorgeous new coronets for Ursula and Irik, in part to end the controversy with Guliermo. They are real silver coronets with celtic knotwork running all the way around the band. For Ursula's coronet, the knotwork is interrupted every four inches with a lozenge bearing Ursula's arms (a bear rampant, surrounded by four pine trees), each lozenge bears a real pearl. For Irik's coronet, the knotwork is interrupted every four inches with a device bearing Irik's arms, each device holds a real pearl. The coronet has a red background with silver knotwork. A bear's head is positioned between each point one on the top and one on the bottom of the coronet. These coronets are demonstrate Dylan's artistic gifts and his love of the barony. He also made beautiful rosewood boxes, lined with velvet and a raised area to securely store and transport the coronets. Upon Irik's death, his coronet was passed to Baron Alexander, when Alexander was given his Grant of Arms and raised to the status of Court Baron.

When Merlinia was invested as Baroness, Dylan made a gorgeous coronet for her similar to Irik's and Ursula's coronets. Because Merlynia's personal arms contain a tower, Dylan put five Morrigen faces on the band and a decorated disk at the back. The coronet is silver hand bent knotwork, lined with blue deerskin. Above the silver roundels are amethyst 'pearls'.



## King and Queen's Archery Championships To Be Held in the Barony of Settmour Swamp

It is with great pleasure that I announce our barony has been selected to host this year's King and Queen's Archery Championships.

This grand event will be held on the first weekend after the summer solstice on June 22, 23 and 24. The best archers in the East will be traveling to the northern reaches of our Barony to test their skill and compete for the honor of being a royal champion.

The event will be held at the Teetertown Ravine Nature Preserve, the Mountain Farm section. This is a new site for us and is located in Lebanon Township, north of Califon. We have a large field for the archery tournament and a separate field for camping and other activities. There is also a wonderful firepit with benches for a bardic circle.

The focus of the event is the archery tournament, however, our fighters and fencers will not be forgotten. Sir Mitchell has offered to run, in his words, "a good, old-fashioned double elim tournament" on Saturday and Lord Edmund, our baronial fencing marshal, is organizing a Southern Region Fencing Practice.

There will be no feast, but dayboard will be provided by Baroness Jessa d'Avondale.

#### Franklin Institute of Science - Philadelphia, PA

Tutankhamen and The Golden Age of the Pharoahs – For the first time in 30 years, the golden artifacts of the boy-king have left their home in Egypt. #### **Nutley Fighter Practice**

Note: Many of the exit ramps from Rt. 3 are sharp curves.

#### From NJ Route 3, Essex/Passaic County (East or West):

Take the Main Ave, Nutley-Passaic exit. At the bottom of the ramp, make left onto Main. Go past Bradlees to the next light, make a right onto Kingsland. Go to the first light and turn left onto Franklin. At the third light make a right onto Chestnut. Go one block and make left onto Hillside Crescent. The church is on the left-hand side; park on the street.

Alternate directions that will help you avoid traffic:

#### From the South:

Take the Garden State Parkway to Exit 151. At the end of the ramp turn right onto Watchung Ave. At the next light make a left onto East Passaic Ave. Take your second right onto Coeyman Ave. Make the first right onto Bromley Place. Bromley Place turns into Glenview Place. You will come to a stop sign at Ridge Road right after a curve (be careful). Continue straight and Glenview becomes Chestnut St. Continue straight through the traffic light at Bloomfield Ave.\* At the top of the hill at Prospect Street Chestnut jogs to the right. Continue on Chestnut. Take the next right onto Hillside Crescent. The church will be on the left after the curve.

#### From Route 3 Eastbound:

Take the Passaic Ave exit. Stay to the right and merge with Ward Ave. At the next intersection (50 ft or so), make a left onto Passaic Ave.

\*\*Passaic Ave turns into Cathedral Ave. Stay to the right at the fork in the road. At the end of Cathedral, make a right onto Kingsland St. Take the first left onto Bloomfield Ave. (across from Roche, at the railroad tracks). Take Bloomfield Ave. to the traffic light at Chestnut St. This should be the second traffic light. (Chestnut is one of those). The three streets on the left before Chestnut are Raymond Ave., Beech St. and Mountainview Ave. Continue from \* above.
