

## **Directions to Practices**

#### Fighter Practices, Moose Lodge, Edison

From I-287 South take Exit #3 – New Durham/Metuchen. Turn RIGHT at light onto New Durham Road. At next light, make a RIGHT onto Talmadge Road. At next light turn LEFT onto Coolidge St. Go 0.2 miles; make a LEFT into Moose driveway/parking lot.

From I-287 North take Exit #2B – New Brunswick/Rte. 27 South. Tamp traffic flows onto Rte. 27 South. At third traffic light turn RIGHT onto Talmadge Road (Sturgis Road). Go 1.8 miles to 3rd light; make a LEFT onto Coolidge St. Turn LEFT into Moose driveway.

#### Youth Fighter Practices, St. Paul's, Flemington

St Paul is located along Route 31 in Flemington, next door to the Hunterdon Medical Center, two miles north of the Flemington Circle From Route 287

Go I-287 to US-202 (Exit 17)., go Southwest on US-202 to Flemington NJ

Make first right in circle to get on NJ-31 North Follow signs to Hospital Make first Left past Hospital onto Gaunt Place, church is on left.

From Route 78 in Pennsylvania

Go East on I-78 to NJ-31 (Exit 17) Then Go South on NJ-31.

Follow signs for Hospital.

Make right onto Gaunt Place church is on Left.

From New Jersey Turnpike south to I-78 WEST/NEW JERSEY TPKE EXT EAST RAMP towards EXITS 14 TO 14C/CARS-TRUCKS-BUSES.

Merge onto I-78 WEST RAMP, Merge onto I-78 W.

Take I-78 EXPRESS Lane W towards GARDEN STATE PARKWAY / CLINTON.

Merge onto I-78 EXPRESS Lane West. I-78 EXPRESS Lane West becomes I-78 W.

Take the I-287 exit, exit number 29, towards SOMERVILLE (US-202/206).

Merge onto I-287 SOUTH RAMP., Merge onto I-287 S.

Take the US-202 SOUTH/US-206 SOUTH exit, exit number 17, towards SOMERVILLE (US-22 W) / FLEMINGTON.

Stay straight to go onto US-202 S. until you reach Flemington Take first Right on circle to stay on NJ-31 North Follow signs to Hospital Make first Left past Hospital onto Gaunt Place, church is on left.

From Garden State Parkway

Go North on GARDEN STATE PKWY (Portions toll) to I-195 (Exit 98).

Go West on I-195 to I-295.

Go North on I-295 to I-95 SOUTH.

Go South on I-95 SOUTH to NJ-31 (Exit 4).

Go Northwest on NJ-31 to Flemington

Take first right on circle to stay on NJ-31 North Follow signs to Hospital Make first Left past Hospital onto Gaunt Place, church is on left.

From Philadelphia

Go North on I-95 NORTH to New Jersey.

Go North on I-95 NORTH to NJ-31 (Exit 4).

Go Northwest on NJ-31 to Flemington

Go 1/2 way around circle to stay on NJ-31 North Follow signs to Hospital Make first Left past Hospital onto Gaunt Place, church is on left.

#### **Nutley Fighter Practice**

Note: Many of the exit ramps from Route 3 are sharp curves.

#### From NJ Route 3, Essex/Passaic County (East or West):

Take the MAIN AVE, NUTLEY-PASSAIC exit

At the bottom of the ramp, make left onto Main.

Go past Bradlees to the next light, make a right onto Kingsland,

Go to the first light, and turn left onto Franklin.

At the third light make a right onto Chestnut

Go one block and make left onto Hillside Crescent. The church is on the left-hand side; park on the street.

Alternate directions that will help you avoid some traffic:

#### From the South

Take the Garden State Parkway to Exit 151., at the end of the ramp make a right onto Watchung Ave.

At the next light make a left onto East Passaic Ave.

Take your 2nd right onto Coeyman Ave.

Take the 1st right onto Bromley Place.

Bromley Place turns into Glenview Place.

You will come to a stop sign at Ridge Road right after a curve (be careful).

Continue straight and Glenview becomes Chestnut St.

Continue straight through the traffic light at Bloomfield Ave.

\*at the top of the hill, at Prospect St, Chestnut jogs to the right. Continue on Chestnut.

Take the next right onto Hillside Crescent. ,the church will be on the left after the curve.

#### From Route 3 Westbound

Take the Passaic Ave exit.

At the end of the ramp, make a left onto Passaic Ave.

Follow directions from \*\* below

#### From Route 3 Eastbound:

Take the Passaic Ave exit.

Stay to the right and merge with Ward Ave.

At the next intersection (50ft or so), make a left onto Passaic Ave.

\*\*Passaic Ave turns into Cathedral Ave.

Stay to the right at the fork in the road.

At the end of Cathedral, make a right onto Kingsland St.

Take the first left onto Bloomfield Ave. (Across from Roche and at the railroad tracks).

Take Bloomfield Ave to the traffic light at Chestnut St. This should be the second traffic light, but there have been lights added to that road since I lived there. (Chestnut is one of those). The three streets on the left before Chestnut are Raymond Ave., Beech St. and Mountainview Ave.

## **Proposed - Barony of Settmour swamp refund policy**

## • Pre- registration refunds:

- Any person who notifies the Autocrat or the person taking the reservations for an event two weeks prior to the event that they will not be able to attend will be given a full refund.
- o If notice is given less then two weeks from the event, the site fee for the day will be refunded but any feast fee refund will be depended on the Baronies ability to resell the seat for feast.
- o No refunds will be sent out prior to the event and not until any checks that have been deposited have cleared the bank.

#### Refunds at troll:

- o If troll is notified that a person will not be showing up they will be placed on the refund list. Site fee will be refunded and the feast fee will be refunded if the seat can be resold. Refunds will be sent out after the event and will only be sent to the person who paid for the reservation.
- Once a person checks into troll no site fee or NMS will be refunded, feast fee will be refunded only if the feast seat can be resold. Again any Refund given will be sent out after the event and will only be sent to the person who paid for the reservation
- O NO REFUNDS WILL BE PAID DIRECTLY FROM TROLL.

#### • After the day of the event:

- o No refunds will be given after the event unless the reservation was able to be resold at troll. All post event refunds must be approved by the Seneschal of the Barony and the Baronial exchaquer.
- All requests for refunds must be received within seven days of the event to be considered. After seven days no refunds will be issued.

#### • Inclement weather:

- o If an event has to be canceled due to severe weather, the officers of the Barony will decide if refunds can be issued. Refunds will only be offered if the Barony has sufficient funds to cover the refunds.
- If there is bad weather but the event is not cancelled refunds will not be issued.
- All refunds will be issued from the Baronies checking account and no refunds will be sent until the deposits have cleared the bank.

#### **Proposed - Settmour Swamp Troll Policy and Procedure**

#### I. Opening

- A. Troll must be informed of any changes to Procedure prior to the opening of the Event. This includes the use of Parking Passes, Site Tokens, etc.
- B. Troll must receive "seed money" before the Event begins.
- C. A standardized Attendance List has been handed down from the Baronial Exchequer. The Site Fee must be changed on the Attendance List and the Event Attendance List must be at Troll before the Event opens.
- D. The Pre-Registered Attendance List must be at Troll at the opening of the Event.

#### II. Signing In

A. All Attendees must sign in to Troll individually regardless of Age or Status.

- B. If a person wants to pay the Site Fee for other attendants, all of the attendants must be listed in the Sign In Sheet individually. The fees can then be added together and the attendant pays for the total site fee.
- C. All attendants must be able to present their proof of membership at Troll during Sign In.
  - 1. If the attendee cannot present their proof of membership during Sign In, they must pay the \$3 Non-Member Surcharge. (See **Proof of Membership**)
- D. Troll must check for pre-registration before signing in the attendant.
  - 1. Pre-registered Attendants must still sign in with Troll as soon as they come in to the event.
  - 2. Pre-registered attendants must still be able to present their Proof of Membership or they must pay the \$3 Non-Member Surcharge.
  - 3. Pre-registered attendants do not have to be listed on the Attendance Sheet. A check mark must be listed next to their name on the Pre-Registered Attendance List and their membership number must still be written beside in the appropriate column.
- E. All fighters must sign in to Troll before going to the List Field.
- F. All fighters must have a Site Token that they may present to the Minister of Lists.

#### III. Proof of Membership

- A. All attendees must provide Proof of Membership upon arrival at Troll.
- B. Proof of Membership consists of:
  - 1. Blue membership card that has been signed.
  - 2. White membership card.
  - 3. Current Pikestaff
  - 4. Letter of Membership printed from on-line registration
- C. Anyone who cannot provide Proof of Membership must pay the \$3 Non-Member Surcharge.

#### IV. Insurance Waivers

- A. All attendance must provide Proof of waiver on File.
  - 1. The only Proof of a waiver on file is if a Member provides his or her signed blue membership card.
  - 2. If a member shows any other form of membership, they cannot provide Proof of Insurance and must sign the insurance waiver.
- B. All minors must have a legal parent or guardian sign an insurance waiver.
- C. Children who can provide a blue membership card do not have to sign an insurance waiver but must still be accompanied by their legal parent or guardian.

#### V. Handling of Cash

- A. Only the Troll-O-Crat or his assigned deputies are authorized to handle any cash during the event.
- B. Only one (1) person may handle the money at any given period.
- C. Regular "cash drops" should be made in \$1000 increments and locked in a blue bank bag.
- D. All "cash drops" must be given to the Exchequer or a pre-arranged Deputy of Exchequer to be established before the opening of the Event.
- E. Volunteers are welcome at Troll but may not handle monies unless authorized by the Troll-O-Crat.
- F. No deputy may authorize any volunteer to handle cash at any given time.
- G. The Troll-O-Crat or one of his/her authorized deputies must be at Troll at all times.
- H. Other volunteers may check the Pre-registration list, sign in attendees, hand out site tokens, etc.
- I. No monies may come out of the Troll box at any time. Any financial disputes or receipts must be resolved with the Exchequer after the Event. (See **Exchequer Policies and Procedures**)

#### VI. Complimentary Attendance

- A. Complimentary Attendance is given to the following people:
  - 1. King to the East
  - 2. Oueen of the East
  - 3. Crown Prince of the East
  - 4. Crown Princess of the East
  - 5. Baron of Settmour Swamp
  - 6. Baroness of Settmour Swamp
  - 7. Event Autocrat
  - 8. Event Feat-O-Crat
- B. Any Complimentary Attendant may waive his/her Complimentary site fee if they so desire.
- C. All Complimentary Attendants must still check in with Troll upon arrival at the Event and must provide Troll with his/her signed, blue membership card.
- D. Should the Complimentary Attendant have any other form of Proof of Membership, he/she must sign the insurance waiver.
- E. The word "Complimentary" should be written on appropriate line of the Attendant and his/her Membership Number must be filled in the appropriate column.

#### VII. Guests

- A. A Complimentary Attendant may pay the site fee or a guest(s).
- B. Only a Complimentary Attendant may inform Troll of a guest. All other guests are to be signed in as per Troll Policy.
- C. If the Complimentary Attendant wishes to have a guest(s) they should inform Troll at the beginning of the Event and they should accompany the guest at Troll during sign in or be able to provide the guest's Real Life name at the beginning of the Event.
- D. The Complimentary Attendant may not use the guest's Society name when informing Troll of the guest.
- E. The guest must exhibit Proof of Membership or the paying party must pay the \$3 Non-Member Surcharge.

#### VIII. Closing

- A. Troll must be resolved at the end of each day of the Event.
- B. The Attendance List must be counted up and resolved at the end of each day of the Event.
- C. A new Attendance List must be started at the beginning of each day of the Event.
- D. Waivers must be given to the Senechal (or the Autocrat if the Senechal is not present) at the end of the Event.
- E. All monies must be given to the Exchequer (or the Senechal if the Exchequer is not present) at the closing of Troll. (See Handling of Cash)
- F. Any monies that are due Troll are to be resolved before the end of the Event unless other arrangements are made with the Exchequer
- G. The Troll box must be packed away neatly and returned to the Chamberlain at the closing of Troll.
- H. Lost and Found must go to the Autocrat at the end of the Event. Troll may watch over Lost and Found but are not responsible for it.
- I. Troll may watch over Gold Key but are not responsible for it.
- J. Gold Key must be returned to the Chatelaine at the end of the Event. (See Chatelaine Policy and Procedures)

#### **East Kingdom Waiver Policy:**

A separate event sign-in sheet shall be maintained in addition to the roster or individual waivers used. The sign-in sheet may be generated locally but shall record only the legal name of the attendee, their SCA name (if applicable) and their membership number (if a member).

## **Quest Obstacles Revealed!**

Quest Obstacle problems redux: for those who didn't get to solve them during the event. Contributed by Galen MacByrne.

1) Innkeeper Offering to the Spirits Logic Problem Water pouring problem

You see an innkeeper and a Buddhist spirit (Christophe and Rachel played the parts at the event). The innkeeper says to you the following:

"You have a cask with an unknown amount of sake, but you know it is more than 8 units. You have 2 measuring devices of known volume, 3 units and 5 units. You cannot mark the containers accurately to get partial measures, you can only fill or empty a container of known volume to give you an accurate measurement.

By pouring sake from one container to another, or spilling it onto the ground as an offering to the spirits around us (he bows to the spirit, who bows back to him), present the spirit with the 3 and the 5 unit containers, each containing exactly 1 unit of sake."

Solution: Fill the 5 and the 3, empty the cask onto the ground

(OMIGOD, alcohol abuse!), close tap on the cask, empty the 3 into the cask, fill the 3 from the 5, empty the 3 into the cask again (leaving 6 in the cask), pour the remainder (2) into the 3 from the 5, fill the 5 from the cask (leaving 1 in the cask), fill the 3 with the 5, (leaving 4 in the 5), drink or empty the contents of the 3 onto the ground, refill the 3 with the 4 left in the 5, drink or empty the contents of the 3 onto the ground again, empty the 1 from the cask into the 3. End.

- 14) End 0 1 1
